Re: Township of Seguin Proposed Application for Minister's Zoning Order

Thank you for your letter and request for comments on the proposed development within your municipality. I am writing on behalf of our Council, who reviewed your correspondence of November 4th, 2021 at our Committee/Council meeting held on December 1st, 2021.

The Municipality of McDougall recognizes the need for additional housing to accommodate a range and mix of options within the West Parry Sound area. However, we have concerns with the use of Section 47 of the Planning Act, seeking a Minister's Zoning Order for the subject lands, as it does not allow for public engagement and open communication and collaboration on this important regional issue.

Respectfully, prior to commenting on the proposal, the Municipality of McDougall feels that further engagement and collaboration with all regional partners and the public is needed. It is requested that the Township of Seguin provide a full assessment of the impact that the Ministers Zoning Order would have within the Municipality of McDougall and area municipalities.

In addition, the Municipality requests any and all additional information on the proposal, including all background information and studies once available (i.e., planning justification, environmental, servicing options, endangered species, traffic impact, impacts to the Town of Parry Sound including various cross boundary issues).

We look forward to receiving additional information for review.

Dear Mayor Jamie McGarvey and Council,

The Muskoka Lakes Chamber of Commerce is writing in support of Seguin Township's timely action to try and move forward with a much-needed housing development on its northern border with the Town of Parry Sound. We have been watching with interest – and excitement -- the plans for this housing development.

What an incredible win – not only for Seguin, but for Parry Sound overall and Muskoka Lakes as well. Our businesses are hurting from staff shortages due greatly to no attainable housing. We hope you will reconsider your November 30th decision that serves to hinder this process.

Frankly, we were shocked and saddened to hear your Council suggest moving ahead was 'premature'. It was our belief that there have been many discussions between Seguin and Parry Sound over the years about addressing the desperate need for residential development.

Some background: For over two decades, the Muskoka Lakes Chamber has been warning about a housing crisis in Parry Sound-Muskoka, and now we are beyond crisis point. At the time, we started a staff housing project that the community embraced, opening their homes to make sure our businesses had staff. But the landscape has changed. With it being more lucrative to Air BnB a room and COVID, no one is willing to rent a room. Our businesses turn customers away because they can not serve them as they have no staff, and no housing to offer staff, etc. Some businesses are buying up other businesses to turn them into staff housing: while we applaud entrepreneurial action to solve a problem, this trend can not be good for our regional economy. Our Chamber has Members in Seguin; many in Rosseau. A housing development would help serve our 359 Members in Parry Sound District and Muskoka Lakes.

We urge Seguin Township and the Town of Parry Sound to move faster, not slower, to make this development a reality. We fully support Seguin Township, and will be writing to the Minister of Municipal Affairs and Housing to ask how they might be able to expedite the process.

We appreciate the work of Parry Sound Town Council, and we know we have our own development hurdles in Muskoka Lakes. However, we felt it important we speak up as the health of our combined and neighbouring business communities are at stake.

In May of 2019, almost three years ago I participated in a Housing Summit put on by Glen Barnden the West Parry Sound Regional EDO.

He "gathered" 64 different organizations together for a whole day to discuss the barriers and possible solutions to the affordable housing shortage in Parry Sound.

I have attached the 3-page report along with Glen's e-mail comments. The overall outcome: There is a Housing Crisis in the Parry Sound Area!

At our airport we have over the last 15 years developed some of our lands into a business park "hub" attracting a variety of businesses and now have 80-100 jobs on the field.

Asking any of the stakeholders what their number one issue in running their business is finding the work force and when you find them their biggest problem is housing.
